## SOCOTEC GROUP ADDS BUILDING CONTROL TO ITS RANGE OF UK SERVICES

The SOCOTEC Group is broadening its range of services in the UK through the acquisition of Butler & Young Group Ltd. B&Y will reinforce SOCOTEC UK, the SOCOTEC Group's UK subsidiary, which is a leading operator in testing in the infrastructure and construction sectors. SOCOTEC is the leader in technical inspection in France, where it generates  $\in$ 100 million in revenue in this field, and is a major European player in TIC<sup>1</sup> and a trusted partner to its client companies.

Formed from Butler & Young Associates in 1970, **Butler & Young Group** is a standard setter in building control in the UK. It was one of the first three UK companies to be appointed approved inspector for all building types in 1997, when the UK market opened up to private players.

Butler & Young Group is headquartered in Croydon, to the south of London, and is composed of three companies:

- Butler & Young Approved Inspectors, for building control
- **Trenton Fire**, for fire safety consultancy
- Butler & Young Consultants, for built-environment consultancy services.

Butler & Young Group's capital has been held by its three main executives, including Paul Wilkins, who has been CEO since 2006 and will stay with the business as Senior Advisor.

**B&Y has 15 offices in the UK**, with 13 in England, one in Wales and one in Scotland. Its **175 employees** cover the **whole of the UK**, with 85 of them working in building control. It generated nearly **€11 million in revenue in 2018**, including €7 million from building control. **Butler & Young Approved Inspectors** has been involved in the technical inspection of more than 80,000 construction projects since 1997 for clients in all sectors of activity.

**Ian Sparks, CEO of SOCOTEC UK**, **says**: "We're very pleased to extend our range of services and move into building control through the acquisition of Butler & Young Group, which is a very well-known name in the UK. Building control and fire consultancy services will become the fourth leg to our UK business, alongside Infrastructure & Energy, Environment & Safety, and Monitoring. This activity will continue to be managed by the current management teams, with Chis Wallis as Managing Director and Dilshard Mansoor as Head of Finance.The UK market is consolidating and offering room for innovation thanks to digitalisation and BIM. Against this backdrop, we aim to boost this activity. The combination of Butler & Young Group's longstanding expertise in building control and our strong sales drive in the UK should provide us with the right platform for rapid growth."

**Hervé Montjotin, SOCOTEC Group CEO, adds**: "This acquisition is completely in phase with our aim to become European leader in TIC<sup>1</sup> by 2020 in the construction and infrastructure sectors. It will reinforce our SOCOTEC UK subsidiary by adding expertise in building control and fire safety consultancy. We are extremely pleased and proud to be able to carry out this longstanding activity in the UK, which is our second platform behind France. With Butler & Young Group, which truly fits into the SOCOTEC Group, our UK platform now has a local flagship in building control that will enable it to take a position as a fully-fledged TIC<sup>1</sup> player in construction and infrastructure."

This transaction comes at a moment when the rollout of the SOCOTEC brand is being stepped up outside of France, with the adoption by the Italian subsidiary of the name SOCOTEC Italia on 5 March, the formation of SOCOTEC Monitoring UK following the acquisition of Survey Associates Limited, and the formation of SOCOTEC Infrastructure Maroc in March.
